

**AccessLine Communications**  
**REFERRAL REWARDS PROGRAM TERMS AND CONDITIONS**

1. Definitions

- a. "AccessLine" means AccessLine Communications, Inc.
- b. "Referrer" means individual or company that provides the information to AccessLine of a potential new AccessLine customer.
- c. "AccessLine Referral Rewards Program" means the program described on <http://www.accessline.com/referrals>

2. The AccessLine Referral Rewards Program is valid only for referrals on new service activations for customers that have not subscribed to that particular service or product within the last year. Offer valid in the U.S. only and cannot be combined with any other offers. Program terms apply only to referrals made after January 25, 2010. Any individual, company, or organization having a commission program in place with AccessLine prior to January 25, 2010 is not eligible for this program.

3. Misuse of the AccessLine Referral Rewards Program may lead to forfeiture of referral payments otherwise due to paid.

4. Use of services associated with the Referral Rewards Program is subject to the AccessLine Terms and Conditions of service as posted and periodically updated on the AccessLine website at [www.accessline.com](http://www.accessline.com).

5. The Referrer is an independent contractor or association or agent of AccessLine. Referrer is not an employee or joint venture partner of AccessLine. Referrer cannot make representations beyond representations located at <http://referrals.accessline.com/>

6. Any customer that becomes a customer of AccessLine by being referred to the service is a customer of AccessLine for the services procured from AccessLine.

7. Payment. Payment for business referrals is made by issuing a check payable to the referrer. Referred customers must sign up for an Individual Monthly Recurring Charge (MRC) based service. Payment will not occur until the referred customer has activated service and has paid their bill for the first two billing periods. The referred customer must be in good standing for 60 days at the time payment is issued. Payment will be forfeited if the referrer's W-9 is not provided to AccessLine within 90 days of the order date of referral. If referred customer does not provide the proper promotion code at the time of service registration, payment is NOT DUE the Referrer, no exceptions.
